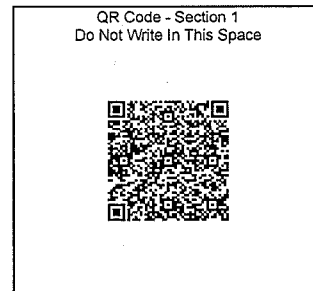

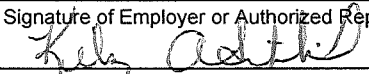

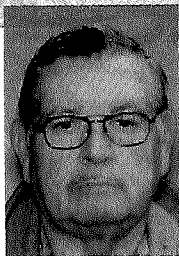

ANTI-HARASSMENT POLICY

NONCOMPETE

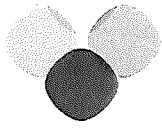
