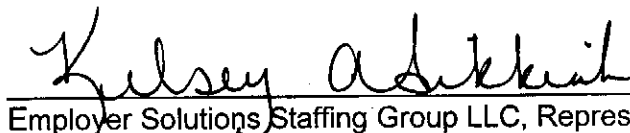

I further understand that this agreement supersedes all prior agreements, understandings and representations concerning my employment with the company.

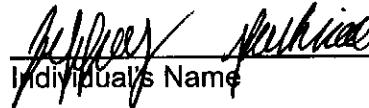
