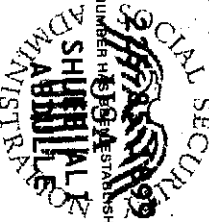

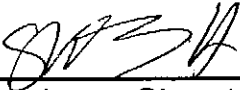
STATEMENT OF CONFIDENTIALITY
