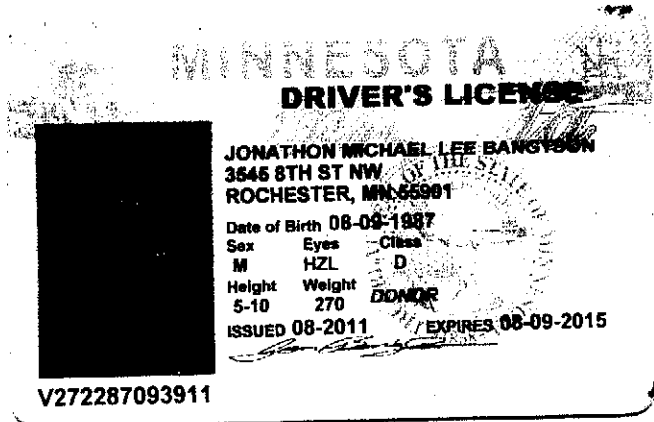
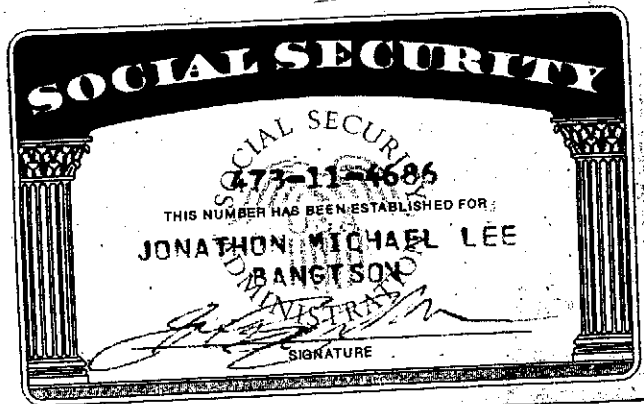

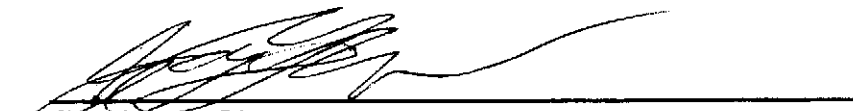
STATEMENT OF CONFIDENTIALITY
