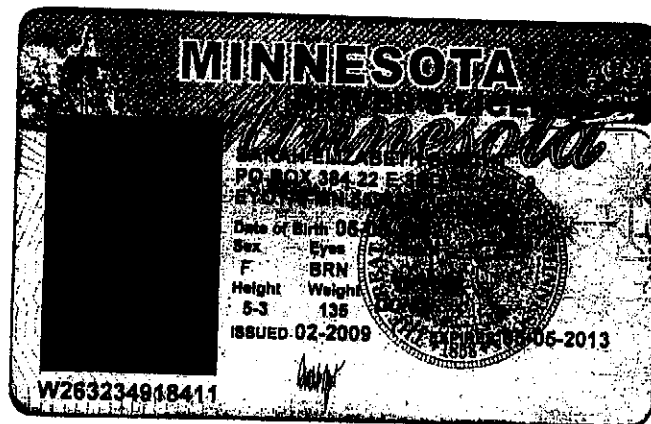

STATEMENT OF CONFIDENTIALITY

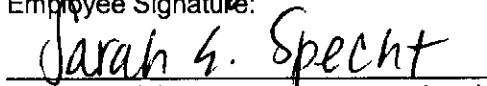
