Pursuant to Judiciary Law, employers, if they employ more than 10 employees, must pay jurors at least the first \$40.00 of their daily wages during the first 3 days of jury service, and if the employer bears this obligation, jurors shall not receive juror fees for the first 3 days. If a juror's daily wages are less than \$40.00 the juror shall receive the difference between \$40.00 and their daily wages. Jurors shall not receive any fees if their employer pays their regular wages during jury service
