# Form W-4 (2017)

**Purpose.** Complete Form W-4 so that your employer can withhold the correct federal income tax from your pay. Consider completing a new Form W-4 each year and when your personal or financial situation changes.

**Exemption from withholding.** If you are exempt, complete **only** lines 1, 2, 3, 4, and 7 and sign the form to validate it. Your exemption for 2017 expires February 15, 2018. See Pub. 505, Tax Withholding and Estimated Tax.

**Note:** If another person can claim you as a dependent on his or her tax return, you can't claim exemption from withholding if your total income exceeds \$1,050 and includes more than \$350 of unearned income (for example, interest and dividends).

**Exceptions.** An employee may be able to claim exemption from withholding even if the employee is a dependent, if the employee:

- Is age 65 or older,
- Is blind, or
- Will claim adjustments to income; tax credits; or itemized deductions, on his or her tax return.

The exceptions don't apply to supplemental wages greater than \$1,000,000.

**Basic instructions.** If you aren't exempt, complete the **Personal Allowances Worksheet** below. The worksheets on page 2 further adjust your withholding allowances based on itemized deductions, certain credits, adjustments to income, or two-earners/multiple jobs situations.

Complete all worksheets that apply. However, you may claim fewer (or zero) allowances. For regular wages, withholding must be based on allowances you claimed and may not be a flat amount or percentage of wages.

**Head of household.** Generally, you can claim head of household filing status on your tax return only if you are unmarried and pay more than 50% of the costs of keeping up a home for yourself and your dependent(s) or other qualifying individuals. See Pub. 501, Exemptions, Standard Deduction, and Filing Information, for information.

**Tax credits.** You can take projected tax credits into account in figuring your allowable number of withholding allowances. Credits for child or dependent care expenses and the child tax credit may be claimed using the **Personal Allowances Worksheet** below. See Pub. 505 for information on converting your other credits into withholding allowances.

**Nonwage income.** If you have a large amount of nonwage income, such as interest or dividends, consider making estimated tax payments using Form 1040-ES, Estimated Tax for Individuals. Otherwise, you may owe additional tax. If you have pension or annuity income, see Pub. 505 to find out if you should adjust your withholding on Form W-4 or W-4P.

**Two earners or multiple jobs.** If you have a working spouse or more than one job, figure the total number of allowances you are entitled to claim on all jobs using worksheets from only one Form W-4. Your withholding usually will be most accurate when all allowances are claimed on the Form W-4 for the highest paying job and zero allowances are claimed on the others. See Pub. 505 for details.

**Nonresident alien.** If you are a nonresident alien, see Notice 1392, Supplemental Form W-4 Instructions for Nonresident Aliens, before completing this form.

**Check your withholding.** After your Form W-4 takes effect, use Pub. 505 to see how the amount you are having withheld compares to your projected total tax for 2017. See Pub. 505, especially if your earnings exceed \$130,000 (Single) or \$180,000 (Married).

## **ANTI-HARASSMENT POLICY**

Implementation of the Affordable Care Act (ACA) of 2010 (the health care reform law) requires that we send you this notice. 

- Employees accepting seasonal assignments in Consumer Order Fulfillment and Consumer Order Entry are required to work the Friday and Saturday after Thanksgiving. Employees in other departments should be prepared to work the Friday after Thanksgiving if requested.

### PERSONAL PROPERTY:

CMG and Leanin' Tree are not responsible for personal property that is lost, damaged, stolen or destroyed. You can be issued an onsite locker for your use as needed. We do ask that you do not bring any valuables to work. Purses, wallets and phones should be stored in a secure place at all times. Please see your onsite lead if you are in need of a secure locker for your valuables.

### BREAKS & LUNCHES:

In order for all of us to remain productive, we all need time to rejuvenate:

- If you work at least 8-10-hour shift, you will receive two paid 15-minute breaks and one unpaid 30-minute lunch break.
  - If you stay on site for lunch you do not need to clock out for lunch.
- Your onsite lead will give you your assigned break and meal periods.

### CELL PHONES:

Use of cell phones are prohibited in the warehouse except those authorized in order to conduct business. Please maintain your phone in a secure place while working.

### INCLEMENT WEATHER CLOSURES:

If the facility closes for Inclement Weather, you will be notified by CMG as soon as we are notified. Please check your phone daily for messages. You can also call the inclement weather hotline at 303-581-2166 prior to your shift.

### SMOKING:

Leanin' Tree is a non-smoking facility. Employees may smoke on breaks or lunch, but only in outside areas specifically designated for smoking. Smoking is not permitted on the walkways around the building or in entrances to the building

### SAFETY, OUALITY, OUANITY:

- Closed-toed shoes are to be worn in production areas.
- Hair must be secured above shoulder level.
- Be careful of moving machinery and equipment including moving tracks and forklifts.
- Use proper lifting techniques or ask for help when lifting or carrying cartons, boxes or other bulky items.

  - Shirts with sleeves must be rolled above the elbow.


**BADGES:**
