PLEASE INCLUDE A COPY OF THIS RECEIPT NOTICE WITH ANY SUPPORTING DOCUMENTS YOU SUBMIT. Such evidence may include, but is not limited to, the following items:

- Lease of joint tenancy or joint ownership of assets
- Joint mortgage agreement and/or property deed
