## Notification of Minnesota Law Requirement- Unemployment Acknowledgement

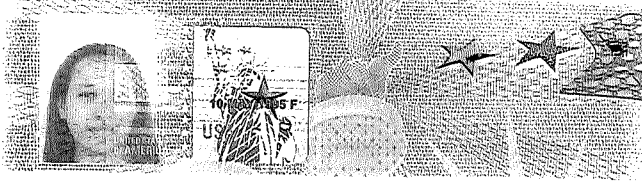
