ORDER FOR ASSIGNMENT OF WAGES


NOW ON THIS February 16, 2016, the Court is advised that the defendant has entered into a voluntary agreement regarding the method of payment of the defendant's financial obligations herein.

The Court, having been fully advised in the premises, finds the defendant's income should be assigned to the Clerk of Court in and for Muscatine County until the defendant's obligations are paid in the amount of \$444.50.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED, that the defendant's income is assigned to the Muscatine County Clerk of Court at the rate of \$30 per WEEKLY pay period and shall be deducted from his wages due and to become due from his employer, Corporate Management Group, whose address is: 12000 N Washington St Ste 350, Thornton CO 80241. At least monthly, the employer shall transmit a check for that amount to the Clerk of District Court, Muscatine County Courthouse, Muscatine, IA 52761.

This wage assignment results from collection of fines and costs initiated by the Muscatine County Attorney's Office in accordance with Iowa Code 331.756(3) and 602.8107(4) and shall remain in effect until the debt has been paid in full.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the defendant shall notify the County Attorney's office prior to any change in employment, and shall be required to make a minimum payment of \$50 monthly during any seasonal lay-off. If the defendant fails to do so, contempt proceedings may be initiated without prior notification.
