CHEMICAL AND MENTAL HEALTH HISTORY

Chemical History: Defendant states that one year ago she completed a lengthy inpatient treatment program at Recovery Plus, followed by additional programming at Welcome Manor and then Journey Home. Her drug of choice at that time was methamphetamine and she denies any use of the drug since completing treatment. Defendant admits that she relapsed twice by using alcohol while at Journey Home, and she also relapsed the date of the current offense. Prior to her arrest defendant reports she was at the bar and was drinking "rum and Cokes," and they were being mixed very strong. Defendant admits she felt intoxicated prior to the current arrest.
